

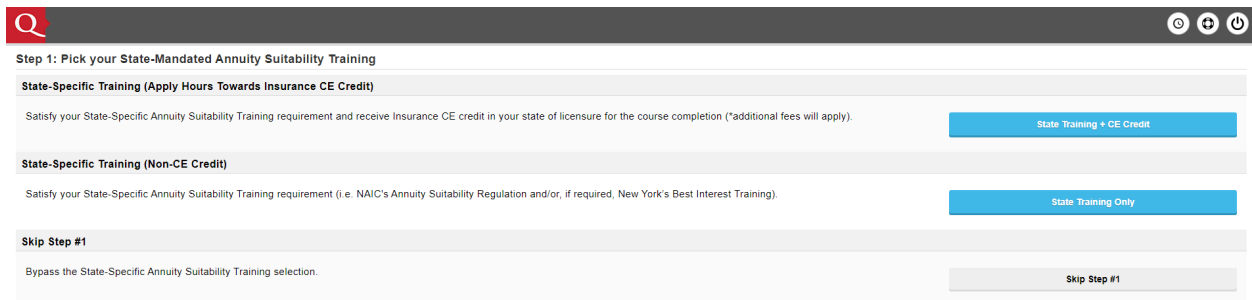
Minnesota Life/Securian Annuity Product Training
